### 2020 - 2021 PreK Information:

#### **Pre-Kindergarten Students:**

Students must be 4 years of age, on or before September 1, 2020 to enroll in pre-Kindergarten. Students younger than 4 or turning four mid-year will not be admitted. Students must be fully potty-trained.

#### **Time & Days:**

Monday and Wednesday, 8:15 – 1:00pm.

- Quarterly field trips will take place on Friday for Pre-Kindergarten students (dependent on COVID-19 guidelines). A parent/guardian is required to attend the field trip with their student.

#### **School year calendar:**

The Mountain View Academy Preschool & Pre-Kindergarten will follow the MVA school year calendar found on the MVA website and in our parent handbook.

#### **Registration:**

The enrollment window is February 1 – 15, 2020. Turn in a completed application and a \$50 non-refundable fee to the MVA office at: 45 S. Moss Street, Lowell, Oregon 97452.

- Pre-Kindergarten: Students must be 4 years of age on or before September 1, 2020.
- **All students must be potty-trained prior to 9/1/20.**

#### **Tuition & information:**

- The tuition for Pre-K students is \$150 per month, September through May. Our school year will go through June, however there will not be a payment made in June. *We are currently working on a grant to offset the cost of pre-Kindergarten. We won't know the outcome of these grants until the summer of 2020. If we receive this grant, it will reduce the cost of this program.*
- The activity fee for pre-K is \$150. This covers all school supplies and field trips for the school year. The \$50 application fee is put towards the total activity fee. Once you have turned in your application and fee, there will only be \$100 remaining on your activity fee balance.
